**FUNDING AND REQUIREMENTS:** Hybl Fellows receive a stipend of \$5,000, to be broken into three increments. Fellows will receive \$2,000 upon the start of the fellowship, \$2,000 midway through, and \$1,000 upon the completion of their research paper. Fellows must complete a paper for public or IFES internal presentation. Fellows have the benefit of mentorship from IFES' international election and democracy experts on staff, and access to IFES research and election materials.
