## INSTRUCTIONS TO VOTERS

PUNCH OUT BALLOT CARD ONLY WITH PUNCHING DEVICE; NEVER WITH PEN OR PENCIL.

A precinct board member will direct you to a voting booth after issuing you the following items:

- a. A long ballot card with space for write-in candidates;
- b. A ballot punch;
- c. A sample ballot pamphlet for the political party with which you are registered.

**STEP 1.** To vote for a candidate of your selection, find his or her name under the title of the office in the sample ballot pamphlet. Note the position number which is shown at the right of the name of that candidate.

**STEP 2.** Place the ballot card on the flat surface of the voting booth. Find the candidate's position number on the card. With one hand, place the tip of the ballot punch on the black dot immediately below the candidate's position number; hold the punch upright and press down firmly. With the other hand, *lift the ballot card* until a rectangular shaped "chad" is completely detached from the card.

**STEP 3.** Where two or more candidates for the same office are to be elected, repeat Steps 1 and 2 for all candidates for that office for whom you want to vote, not to exceed, however, the number of candidates to be elected.

**STEP 4.** To vote for a qualified *write-in* candidate, write the name of the office and the person's name on the lines provided on the ballot card.

**STEP 5.** To vote on any measure, note the position number which is shown at the right of the word "YES" or the right of the word "NO" and follow the procedure described in Step 2.

**STEP 6.** Fold the ballot card at the perforation (as demonstrated at the polls), with the stub showing, and return it to the precinct board member.

All distinguishing marks or erasures are forbidden and make the ballot void.

If you wrongly punch, tear or deface the ballot card, return the ballot to the precinct board member and obtain another.

**STATE PROPOSITIONS** The state propositions begin with No. 42. Legislation requires that state propositions be consecutively numbered for 20 years. Proposition No. 1 will not appear again until 2004. Information and arguments concerning the state propositions will be mailed in a separate pamphlet from the office of the Secretary of State.

- 42 VETERANS BOND ACT OF 1986.** This act provides for a bond issue of \$850,000,000 to provide farm and home aid for California veterans. YES 134 →  NO 135 →
- 43 COMMUNITY PARKLANDS ACT OF 1986.** This act provides for a bond issue of \$100,000,000 to provide funds for acquiring, developing, improving, rehabilitating, or restoring urgently needed local and regional parks, beaches, recreational areas and facilities, and historical resources. YES 136 →  NO 137 →
- 44 WATER CONSERVATION AND WATER QUALITY BOND LAW OF 1986.** This act provides for a bond issue of \$150,000,000 to provide funds for water conservation, groundwater recharge, and drainage water management, and clarifies language in the Clean Water Bond Law of 1984. YES 139 →  NO 140 →
- 45 DEPOSIT OF PUBLIC MONEYS IN CREDIT UNIONS.** Authorizes Legislature to provide for deposit of public moneys in any credit union. Fiscal Impact: No direct fiscal effect. Legislation already approved implementing measure could result in greater interest income to state and local governments. YES 142 →  NO 143 →
- 46 PROPERTY TAXATION.** Provides exception to property tax limit when acquisition or improvement of real property approved by two-thirds of voters. Fiscal Impact: By itself, measure has no fiscal effect. No increase can occur in local property tax rate unless bond issue is approved by two-thirds vote. State costs for tax relief programs could increase. State income tax revenues could decline as taxpayers deduct greater amounts for property tax payments. YES 146 →  NO 147 →
- 47 ALLOCATION OF VEHICLE LICENSE FEE TAXES TO COUNTIES AND CITIES.** Requires allocation of Vehicle License Fee taxes to local governments. Fiscal Impact: Measure would have no direct fiscal effect. Prevents Legislature from changing the law to take vehicle license fees away from counties and cities. Measure would not prevent state reducing other forms of aid to local governments or changing existing formula for dividing vehicle license fee revenues between counties and cities. YES 150 →  NO 151 →
- 48 LEGISLATORS' AND JUDGES' RETIREMENT SYSTEMS.** Limits retirement allowances for persons entering Legislators' and Judges' Retirement Systems after January 1, 1987. Fiscal Impact: Minor savings to state in future years if rate of inflation exceeds increase in salaries paid to current officeholders. YES 153 →  NO 154 →

- 49 NONPARTISAN OFFICES.** Prohibits a political party or party central committee from endorsing, supporting, or opposing a candidate for nonpartisan office. Fiscal Impact: No direct state or local government fiscal impact. YES 160 →  NO 161 →
- 50 PROPERTY TAXATION. DISASTERS.** Base-year value of property damaged or destroyed by disaster transferable to comparable replacement property in same county. Fiscal Impact: Local property tax revenues would decrease by an unknown amount. County assessors and tax collectors would have nonsignificant higher administrative costs. State would replace revenues lost by school and community college districts. State income tax revenues could increase due to lower property tax deductions on replacement properties. These state costs and revenues cannot be estimated. YES 163 →  NO 164 →
- 51 MULTIPLE DEFENDANTS TORT DAMAGE LIABILITY.** Plaintiff's non-economic damage recovery limited to defendant's liability based on defendant's percentage of fault. Fiscal Impact: Substantial savings to state and local governments. Savings could be several millions of dollars in a year, varying significantly from year to year. YES 167 →  NO 168 →
- 52 COUNTY CORRECTIONAL FACILITY CAPITAL EXPENDITURE BOND ACT OF 1986.** This act provides for the construction, reconstruction, remodeling, and replacement of county correctional facilities and the performance of deferred maintenance thereon pursuant to a bond issue of \$495,000,000. YES 170 →  NO 171 →

## INFORMATION FOR HANDICAPPED VOTERS

The staff in Voter Registration and Elections have attempted to locate and use polling places that are accessible to persons with limited mobility. A notation appearing on the label of your Sample Ballot indicates whether or not your polling place is accessible to the physically handicapped. If the notation is in error, please notify the Polling Place Section of the department at (916) 366-2051.

If your polling place is "Not Accessible to the Handicapped" there are several ways you can cast your ballot.

1. If you have limited mobility but are not in a wheelchair, your polling place may be accessible to you. Call the polling place section of the department at (916) 366-2051 for specific information regarding limits to accessibility.
2. You may vote by Absentee Ballot. See the inside back cover for information concerning Absentee Voting.
3. You may appear outside your assigned polling place, at the nearest place accessible to you, (hallway, parking lot, automobile) and request that a ballot be brought to you. After you have voted your ballot the precinct official will return it to the polling place and deposit it in the ballot box.

JUDGE OF THE SUPERIOR COURT, OFFICE NO. 5**

**RONALD B. ROBIE**

**AGE: 48**

**Occupation:** Judge of the Municipal Court

**Qualifications:** Judge Robie, a respected and experienced trial judge, has broad community support. Business, labor and law enforcement leaders endorse him, including the Sacramento County Deputy Sheriff's Association and the California Council of Police and Sheriffs. He is endorsed by many elected officials, including judges, all Sacramento City Councilmembers and a majority of the Board of Supervisors.

Judge Robie is an active, hardworking, no-nonsense judge who is tough but fair. He presides over both criminal and civil cases. He will uphold the death penalty.

**TED D. BLANCHARD**

**Occupation:** Counselor at Law

**Qualifications:** This year Sacramento voters will have the opportunity to decide between two different judicial points of view. The incumbent shares the activist view of her mentor Chief Justice Rose Bird. I believe that our courts should be held accountable for their actions. The incumbent, a last minute appointee of Jerry Brown, believes that leniency has its place in our legal system. I believe in the deterrent value of swift and sure punishment, including the death penalty.
