## **NEW VOTER REGISTRATION FORM**



he Secretary of State's office in conjunction with the California Association of Clerks and Election Officials have redesigned California's Voter Registration Card (VRC) to enhance efficiency and effectiveness of the registration process. Sally Walker, of the Secretary of State's office and Jerry Neeley of the Sacra-

mento County Elections Department co-chaired the project for the past two years.

The new VRC utilizes form-processing technology that will allow elections officials to scan the new card to capture information, rather than to manually input data, which could result in substantial cost savings. Specifically, the new card is designed to:

- ✓ increase efficiency and accomplish more work in less time using less human resources
- $\square$ improve recognition of critical information for the potential voter

- provide additional access to data information for county elections officials:
- to accommodate future enhancements, such as digital technology.

Several counties have participated in a pilot program to test the feasibility of the new form. Results have been extremely positive. ## THE HALL OF FAME

The Voter Participation Unit of the Secretary of State's office has reviewed the 15 nominations submitted for this year's Voter Participation Hall of Fame Awards. There were four categories in which to nominate: 1) individual; 2) community-based organization; 3) business; and 4) local government entity. The nominations were solicited to county elections officials, members of the Legislature and voter outreach organizations. Of the 15 nominations, the Participation Unit has recommended that each of the following be inducted to this year's Hall of Fame:

#### Category: Individual

Nominee: Ethel Irish Coplen

#### Nominated by: Rosalyn Lever, Orange County Registrar of Voters

For more than 66 years Ethel Coplen has been giving her time and talents each election year to work in her polling place. She became involved back in 1932, the year Franklin D. Roosevelt defeated President Hoover. Over the years, Ethel has been involved in many different community activities, but she says now most of her civic duty goes to staffing the polls on election day. She says, "I am dedicated to doing this because I think everybody should vote. No one should complain about government if they don't vote."

#### **Category: Individual**

#### Nominee: Sister Ethel Mary Tinneman

#### Nominated by: Brad Clark, Alameda County Registrar of Voters

For more than twenty-five years Sister Ethel Mary Timmeman, an educator at Holy Names College, has consistently been the backbone of voter registration in Alameda County. Long before it was fashionable, Sister Ethel Mary was working in the most impoverished areas of Oakland, walking alone in the housing projects, going door-to-door in the neighborhoods and setting up tables in front of supermarkets to register voters. Sister Ethel Mary has also imbued in her students the need to get involved in the community, especially with voter registration. She was the driving force in recent years behind developing the candidates forum for the Oakland League of Women Voters.

#### **Category: Community-Based Organization**

#### Nominee: Bell Gardens High School Staff.

Janet Johnson, Assistant Principal. John O'Hara, Government Teacher; Bill Mayoral, Student Activities Director. Nominated by: Conny B. McCormack, Los Angeles County Registrar of Voters & Ron Hart, City Clerk, Bell Gardens. For the past three major elections Janet Johnson, Assistant Principal, John O'Hara, Government Teacher and Bill Mayoral, Student Activities Director, have actively and enthusiastically promoted Bell Gardens' participation in three voter participation programs: "Election Night Volunteers," "Student Pollworker Program" and "In-School Elections." More than 200 Bell Gardens students and teachers have participated in the "Election Night Volunteer" program in the last two elections. Furthermore, the Bell Gardens High School staff conduct a variety of "In-School Election Programs" that mirror real world elections. Students and staff simulate the real election by registering, voting on paper ballots, and in fact, they even have "I voted stickers."

#### **Category: Community-Based Organization**

#### Nominee: Unique People's Voting Project - Shawn Casey O'Brien

#### Nominated by: Secretary of State's Voter Participation Team

The Unique People's Voting Project is an on-going non-partisan voter registration/education project of disabled citizens and their families. It has been instrumental in registering more than 15,000 citizens (disabled and otherwise), many of whom live in the daily realities of developmental or physical disabilities. Working closely with a number of Area Boards and Self-Advocacy Groups, it has also developed strategies that turn people into instant organizers. Its aim is to give all citizens with disabilities non-partisan educational materials - on issues of concern in their communities - in an easy to use "question and answer" format. As part of its 1998 effort, Unique People's Voting Project and thousands of disabled citizens held the first ever Permanent Absentee Ballot Day on October 23, 1998. The objective was simple, to get tens of thousands of citizens with disabilities to cast their votes via Permanent Absentee Ballots and then mail them in on the same day.

#### Contra Costa County: Absentee Voting

Stephen Weir, Contra Costa County Clerk-Recorder, has issued a report on the November 3, 1998 General Election. The report highlights the county's observations on various election related issues, in particular on absentee voting. In fact, Contra Costa County has made great progress in improving the processing of their absentee ballots. They have reduced the occurrence of late absentee ballots by 60.7 percent. They have also reduced their "rejected" category of absentee ballots by nearly 57 percent and reduced the occurrence of no signature absentee ballots by 43 percent. 
#### City of Stockton: Voter Outreach


#### City of Norco: Voter Outreach
