

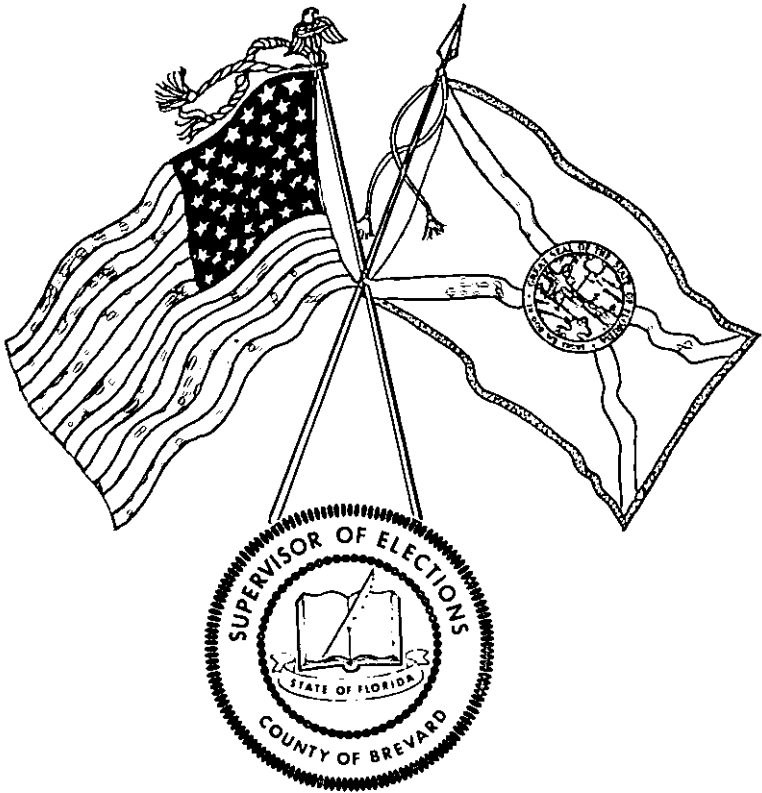

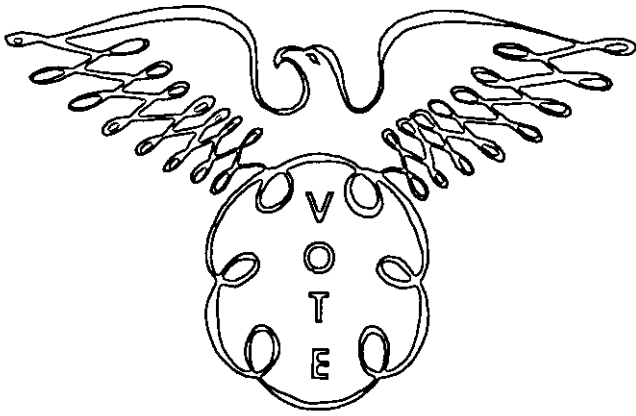

QUALIFICATIONS TO REGISTER

(CHAPTER 97.041 (1), F.S.)

Persons must be at least 18 years of age, or attain age 18 on election day, must be a citizen of the United States and a permanent resident of Brevard County. (Proof of Age and Residence Required.)

ABSENTEE REGISTRATION

(CHAPTER 97.063, F.S.)

The following persons are entitled to register absentee if otherwise qualified:

- (a) Members of the armed forces while in the active service and their spouses and dependents;
- (b) Members of the merchant marine of the United States and their spouses and dependents;
- (c) Citizens of the United States who are permanent residents of the State and are residing outside the territorial limits of the United States and the District of Columbia, and their spouses and dependents when residing with or accompanying them;
- (d) Citizens of the United States who are permanent residents of the State and are temporarily residing outside the State, or who are residing within the State but temporarily outside the County of their permanent residence;
- (e) Residents of the State who are physically disabled and unable to register in person; and
- (f) Residents of the state who are unable to register in person.

Upon receipt of the duly executed federal postcard application or other such request for absentee registration by persons listed in Section 97.063, F.S., the Supervisor of Elections shall mail to the applicant an absentee registration form if the applicant has never registered in the county or if the applicant has registered and has failed to re-register.

REMOVAL & REINSTATEMENT OF REGISTRATION

(CHAPTER 98.081, F.S.)

A name may be temporarily withdrawn from the registration books when the elector fails to respond to a notice from the supervisor indicating he has not voted or updated his registration records during the past 2 year period. Removal may also take place when first class mail sent by the supervisor to the elector is returned undeliverable. A name shall be restored to the registration records when the elector, in writing, makes known to the supervisor that his status has not changed. The supervisor shall then reinstate the name on the registration books without requiring the elector to re-register.

ADDRESS CHANGES (CHAPTER 97.1031, F.S.)

If your permanent address changes in any way, fill in the back of your voter I.D. Card and return the card by mail or in person to any of the Election Offices and a new Registration I.D. Card will be mailed to you.

It is very important that you notify the Supervisor of Elections immediately of any change in your address, mailing or residence.

NAME CHANGES (CHAPTER 97.1031, F.S.)

It is the duty of the elector to notify the Supervisor of any change in his record with reference to name by marriage or other legal process. Name changes may be requested in person or in writing at any one of the Elections Offices.

PARTY CHANGES (CHAPTER 97.072(2), F.S.)

Electors may change their party affiliation at any time the books are open. The only exception is that no party changes are accepted between the primaries and general election. Party changes may be requested in person or in writing at any one of the Elections Offices.

PERSONS NOT ENTITLED TO REGISTER OR VOTE

(CHAPTER 97.041(3), F.S.)

The following persons are not entitled to register or to vote:

- (a) Persons adjudicated mentally incompetent in this or any other state and who have not had their competency restored pursuant to law.
- (b) Persons convicted of any felony by any court of record and whose civil rights have not been restored.

BOOKS CLOSE FOR REGISTRATION (Chapter 98.051(3)(a), F.S.)

First Primary & Second Primary, August 6, 1990, 5:00 P.M.

General Election, October 8, 1990, 5:00 P.M.

The registration books shall close at 5:00 P.M. on the 30th day before an election and shall remain closed until after such election, during which time no registration or party change shall be accepted for such election. The First and Second Primary elections shall be treated as one election period. When the books are closed for an election, registration and changes in registration will be accepted for future elections. Should the thirtieth day preceding an election fall on a Sunday or legal holiday, the registration books shall close at 5 p.m. on the immediately succeeding day which is not a Sunday or legal holiday.

ELECTIONS

FIRST PRIMARY ... is held in early September of even-numbered years to choose party candidates for the general election. You may vote for political party candidates (Democratic or Republican) only if you are registered in that party. It is followed later by the ...

SECOND PRIMARY ... or run-off if, in any race on the ballot, one candidate did not receive a majority of the votes.

GENERAL ELECTION ... is held in November of even-numbered years. Voters may vote for any candidate or issue on the ballot. All registered voters may vote in a General Election regardless of party affiliation.

PRESIDENTIAL PREFERENCE PRIMARY ... is held in March every four years to instruct party delegates as to the party members' choice for president.

REFERENDUM ... may be called at any time on any matter requiring a vote of the people. All voters may vote regardless of party affiliation.

CITY ELECTION (NON-PARTISAN) ... candidates run without party affiliation and all voters may vote regardless of party affiliation. City elections in Brevard County are held in November.

NOTE: Judicial office (non-partisan) candidates run without party affiliation at the first primary election. Any necessary run-offs are placed on the general election.

VOTING AT THE POLLS

The elector desiring to vote is required to identify himself to the Election Board Inspectors by presenting his Voter Identification Card or a Driver's License. After the inspector verifies the elector's name and address the elector signs the Precinct Register. The elector is handed a ballot in a secrecy envelope and he is then directed to a voting booth and allowed 5 minutes to vote. Upon completing voting, elector places the ballot back into the secrecy envelope and returns the ballot to the inspector at the Ballot Box. The inspector removes the stub of the ballot and hands the ballot back to elector for him to place in Ballot Box.

ABSENTEE VOTING

(CHAPTER 97.021(8) & 101.84, F.S.)

The Florida Election Code defines an absent elector as any registered and qualified voter who:

- (a) Is unable without another's assistance to attend the polls;
- (b) Is an inspector, a poll worker, a deputy voting machine custodian, deputy sheriff, supervisor of elections or deputy supervisor who is assigned to a different precinct than that in which he is registered to vote;
- (c) On account of the tenets of his religion, cannot attend the polls on the day of a general, special or primary election;
- (d) Has changed his residency to another county in Florida within the time period during which the registration books are closed for the election for which a ballot is requested;
- (e) Will not be in the county of his residence during the hours the polls are open for voting on the day of an election;
- (f) Has changed his residency to another state and is ineligible under the laws of such state to vote in the general election; however, this shall pertain only to presidential ballots.

REQUEST FOR ABSENTEE BALLOT

(CHAPTER 101.82, F.S.)

An Absentee Ballot request must be made by the elector or person designated by elector. Request may be made in person, by mail or by telephone.

Electors may indicate on one request that they will need to receive ballots for all elections held within a calendar year.

Ballots will be available in the main office Titusville, Merritt Island Branch and Melbourne Branch.

To be counted, voted ballots must be received by Supervisor of Elections in Titusville by 7:00 P.M. Election Day.

TESTING OF TABULATING EQUIPMENT

(CHAPTER 101.5612, F.S.)





Not more than ten days prior to election day, the automatic tabulating equipment shall be tested to ascertain that the equipment will correctly count the votes cast for all offices and on all measures. A legal notice will be published at least 48 hours prior to that date stating the time and place of the tests. For 1990 elections the testing dates will be:

- First Primary August 29
- Second Primary October 1
- General Election November 5

DATAVOTE PUNCHCARD VOTING SYSTEM

VOTER INSTRUCTIONS

VOTE ONE BALLOT CARD AT A TIME – VOTE BOTH SIDES OF EACH BALLOT CARD

<p>1 From the left side of the punching device, place the ballot card under the plastic shield. The card must lie completely flat within the holding tray of the punching device. Make sure the card is as far in as it will go for the punch to actuate.</p> 	<p>2 Slide the punching arm to the candidate or issue of your choice in the first contest. The red arrow on the punching arm should be point-to-point with the arrow on the ballot card which indicates the voting position of your choice in that contest.</p> 
<p>3 Firmly depress the punching lever and release to record your vote. Move the punching lever to the voting position of your candidate in the next contest and repeat the punching process. When you have completed voting the ballot card face, turn it over, re-insert the card and vote all contests.</p> 	<p>4 When you have voted both sides of all ballot cards, place the cards in the black ballot holder with stub ends sticking out at the top. Deliver the ballot holder containing the cards to the ballot box officials.</p> 

WRITE-IN VOTE

(General Election Only)
Write the name of your candidate in the blank space provided in the contest and punch that voting position. Florida law does NOT permit write-in voting in Primary Elections.

OVERVOTE

Do NOT vote for more than the number of candidates to be elected in each contest.

DAMAGED BALLOT

If you make an error or damage any ballot card punch out all voting positions as far as you have voted. Then return all ballots to the judges from whom you received them. Replacement ballot cards will be issued.

CANDIDATES QUALIFICATION DATES

Candidates for Federal Office qualify from noon, May 7, through noon, May 11, 1990.

All candidates for state, county and Nonpartisan Judicial offices qualify from noon, July 16 through noon, July 20, 1990.

Write-in candidates qualify from noon, July 16 through noon, July 27, 1990.

U. S., State and Nonpartisan Judicial except County Court Judge candidates qualify with the Division of Elections in the Department of State, Tallahassee.

County including County Court Judge candidates qualify with the Supervisor of Elections' Office, Titusville.

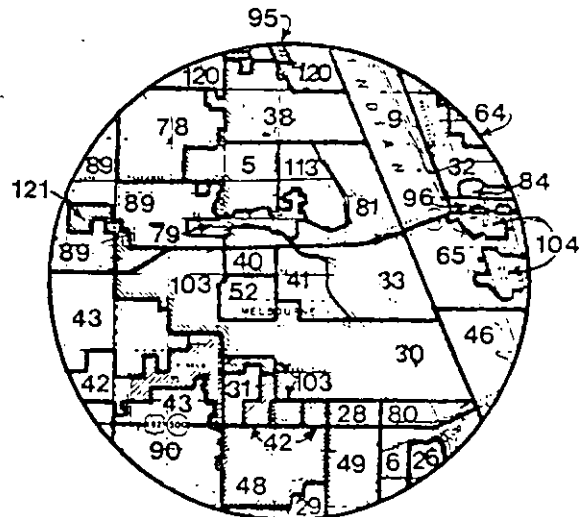
