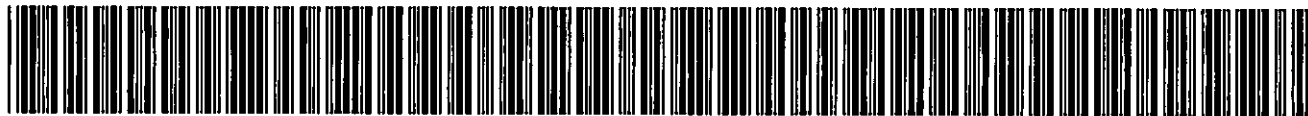

MISSOURI PRIMARY ELECTION

August 8, 2006 is the date for the Missouri Statewide Primary Election. The polls are open from 6:00 a.m. until 7:00 p.m. If you are unable to go to your polling place on August 8, you may vote absentee by contacting your local election authority:

Missouri has four (4) political parties on the Primary ballot: Democrat, Republican, Libertarian and Green

Missouri does not require voters to be formally registered in a political party. However, you may only vote in one party's primary. When you vote in a primary, you must tell the election judge which party's ballot you want. Then you vote for the candidate(s) of your choice.

ELECTION DEADLINES

Tuesday, June 27	Absentee Voting opens at 8:00 a.m.
Wednesday, July 12	Closing date for new voter registration for the August 8 Primary
Saturday, July 15	Election authorities should be open for four (4) hours for absentee voting. Check with your local election authority. They may also be open other Saturdays.
Wednesday, August 2	Last day to request an absentee ballot by mail, by 5:00 p.m.
Monday, August 7	Last day to vote absentee in person, by 5:00 p.m.
Tuesday, August 8	Polls are open 6:00 a.m. to 7:00 p.m.

CONSTITUTIONAL AMENDMENT NO. 1

Proposed by the 93rd General Assembly
(First Regular Session) SJR 1

Shall Article IV, Section 47 (a), (b), and (c) of the Missouri Constitution be amended to:
A) reauthorize for ten years the one-tenth percent sales/use tax for (1) soil and water conservation; (2) state parks and historic sites; and B) resubmit this issue to a vote every ten years or at an earlier special election?

The proposed constitutional amendment continues until 2016, but does not increase, the existing sales and use tax of one-tenth of one percent that is set to terminate in 2008. The tax would generate approximately \$82 million annually for soil and water conservation efforts and operation of the state park system.

Explanation of ballot issue

In 1984 the citizens of Missouri voted for a tax to be used for soil and water conservation and for state parks and historical sites. (The monies do not fund the Department of Conservation.) The amount is 1/10th of one per cent state sales tax. Since the adoption of this article to the Missouri Constitution, voters have periodically renewed the tax. The last two times was for a period of ten years. The current amendment expires in 2008.

Amendment 1 asks voters to:

- 1) Approve the tax for soil/water conservation programs and state parks and historical sites for another ten years.
- 2) The amendment does not change the amount of the tax. The amendment allows for the tax to be submitted to the voters every ten years for approval without further legislation or an initiative petition. (Up to now there was legislation or an initiative petition to place the tax before the voters.)

It is estimated the tax will generate \$82 million a year.

A YES vote means the tax shall remain in place through June 20, 2018, and will be resubmitted AUTOMATICALLY (the purpose of the amendment) in 2016.

A NO vote means the tax will terminate on November 8, 2008. If the tax is not approved, there are no other plans to fund these areas.

AUGUST, 2006 PRIMARY ELECTION VOTING PROCEDURES

- Register to vote by July 12, 2006. If you have changed your name or moved, you will need to notify the Board of Elections or County Clerk to be eligible to vote.
- At the polls, show identification with your signature: Missouri driver's license, Missouri state identification card, social security card, or Missouri college I.D.
- The Election Judge will find your name in the list of registered voters and have you sign and verify your address.
- Tell the Election Judge which party's ballot you want.
- Because of the implementation of HAVA (Help America Vote Act) the voting equipment at your polling place may have changed. If you are in doubt about how to use the voting equipment, ask a poll worker to help you; or, you can check with your election authority before going to the poll.

VOTER'S BILL OF RIGHTS

YOU HAVE THE RIGHT TO:

- Cast your ballot free from interference in a private and secret manner unless assistance is requested.
- View written instructions on how to obtain a ballot for voting, how to vote and prepare the ballot for deposit in the ballot box.
- Ask for and receive further instructions from election judges concerning the manner of voting.
 - View a sample ballot in the polling place before voting.
 - Cast a vote if you are in line before the polls are closed at 7:00 p.m.
- Ask to have the election judges or person of your choice assist you in voting if you cannot read, are blind, or have any other physical disability and cannot vote your ballot, request curbside voting or a more accessible polling location if needed.
- Receive another ballot if your ballot is accidentally spoiled or you make an error.
- Vote on statewide candidates and issues and federal candidates by provisional ballot if the election judges or the election authority cannot determine your registration status.
 - Vote by absentee ballot when permitted by law.
- File a grievance with the Missouri Secretary of State's office if your rights under the Help America Vote Act, Title III, have been violated.
