NEBRASKA WANTS YOU TO VOTE

32-102. Elector shall mean every person of the constitutionally prescribed age or upwards, and who shall have the right to vote for all officers to be elected to public office, and upon all questions and propositions lawfully submitted to the voters at any and all elections authorized or provided for by the Constitution or laws of the State of Nebraska; Provided, no person shall be qualified to vote at any election unless such person shall be a resident of the state, county, precinct, township, or ward on or before election day, and shall have been properly registered with the county clerk or election commissioner, and shall be a citizen of the United States.

32-216 (Excerpt) (3) The office of the election commissioner or county clerk shall remain open during the usual business days of the entire year for purposes of general registration and revision, as required by subsection (1) or (2) of this section, and for the transaction of the business of such office. Such registration and revision shall be carried on and held open at all times during the regular business hours of the election commissioner's or county clerk's office, as the case may be, to and ending at six p.m. on the second Friday preceding any election, including school elections.

(REGISTRATION ONLY)

Any elector absent from the county of his residence, who may qualify to vote may register by mail during the regular registration period. (Excerpt from 32-221)

(REGISTRATION AND ABSENT BALLOT COMBINATION)

Any elector absent from the county may be registered with absent voters ballots by filling in the required information on the two registration forms accompanying the absent voters ballot and subscribing to such registration under oath. (Excerpt from 32-221)

When an application from a person requesting a ballot who is not registered, reaches the county clerk or election commissioner by mail or other means than by the applicant in person, the county clerk or election commissioner shall mail to such applicant, postage paid, registration forms and ballots as provided by Section 32-221. (Excerpt from 32-806)

(STUDENT REGISTRATION)

Students who are registered to vote in the county in which the university, college, etc. is located who move from one dormitory to another, or to an apartment or other dwelling, each new school term will be required to reregister. A change of address cancels a voter registration.

Students may register with the county clerk or election commissioner in the county where the student's parents reside during the time they are classified as a student. Students registering at the home of their parents would not cancel their voter registration when returning to school and establishing living quarters in another dormitory, apartment or dwelling during the school term.

Voter registration and the mailing of absentee and disabled ballots is conducted by the County Clerk at each county seat listed below, except for Buffalo, Dawson, Douglas, Hall, Lancaster, Platte and Sarpy Counties. Voter registration and elections in these seven counties is conducted by the Election Commissioner.

ABSENT, DISABLED AND CONFINED VOTERS
PRIMARY ELECTION MAY 11, 1982

ABSENT VOTERS

Voters who will be absent from the county on May 11, 1982 may vote in person at the office of the county clerk or election commissioner during the usual business hours of the office April 6 through May 10, 1982, 4 o'clock p.m.

Absent voters applying for ballots by use of the United States mail may make application to the county clerk or election commissioner in the county of their residence February 10 through May 7, 1982, 4 o'clock p.m.

The application shall be signed by the voter, his or her spouse or parent and shall state the voter's political party, registration address, and address outside the county where the ballots are to be delivered.

Absent voters ballots returned by the United States mail shall be in the hands of the issuing officer no later than 10 o'clock a.m. the second day after election.

DISABLED VOTERS

Disabled voters applying for ballots by use of the United States mail may make application to the county clerk or election commissioner in the county of their residence April 6, through May 7, 1982, 4 o'clock p.m.

Disabled voters may obtain ballots by appointing an agent to personally pick up the ballots during the usual business hours of the county clerk or election commissioner April 6, 1982 through May 11, 1982, 12 o'clock noon.

The applications shall be signed by the voter, his or her spouse, parent, son or daughter or any other person acting as agent and shall state the voter's political party, registration address and address where ballots are to be delivered.

No candidate or any person serving on a committee for a candidate shall act as agent for any disabled voter.

Disabled voters ballots shall be returned to the issuing officer no later than the hour established by law for the closing of the polls on election day.

CONFINED VOTERS

Any voter confined by public order and who has not been convicted of treason or a felony under the laws of this state or of the United States applying for ballots by use of the United States mail may make application to the county clerk or election commissioner in the county of their residence April 6, through May 7, 1982, 4 o'clock p.m.

Confined voters may obtain ballots by appointing an agent to personally pick up the ballots during the usual business hours of the county clerk or election commissioner April 6, through May 11, 1982, 12 o'clock noon.

The applications shall be signed by the voter and shall state the voter's political party, registration address and address to where ballots are to be delivered.

Confined voters ballots shall be returned to the issuing officer no later than 10 o'clock a.m. the second day after election.

REGISTRATION

Voter registration for the May 11, 1982 primary election closes at 6 o'clock p.m. April 30, 1982.

ABSENT, DISABLED AND CONFINED VOTERS
GENERAL ELECTION NOVEMBER 2, 1982

ABSENT VOTERS

Voters who will be absent from the county on November 2, 1982 may vote in person at the office of the county clerk or election commissioner during the usual business hours of the office September 28, 1982 through November 1, 1982, 4 o'clock p.m.

Absent voters applying for ballots by use of the United States mail may make application to the county clerk or election commissioner in the county of their residence August 4 through October 29, 1982, 4 o'clock p.m.

The application shall be signed by the voter, his or her spouse or parent and shall state the voter's political party, registration address, and address outside the county where the ballots are to be delivered.

Absent voters ballots returned by the United States mail shall be in the hands of the issuing officer no later than 10 o'clock a.m. the second day after election.

DISABLED VOTERS

Disabled voters applying for ballots by use of the United States mail may make application to the county clerk or election commissioner in the county of their residence September 28, through October 29, 1982, 4 o'clock p.m.

Disabled voters may obtain ballots by appointing an agent to personally pick up the ballots during the usual business hours of the county clerk or election commissioner September 28, 1982 through November 2, 1982, 12 o'clock noon.

The applications shall be signed by the voter, his or her spouse, parent, son or daughter or any other person acting as agent and shall state the voter's political party, registration address and address where ballots are to be delivered.

No candidate or any person serving on a committee for a candidate shall act as agent for any disabled voter.

Disabled voters ballots shall be returned to the issuing officer no later than the hour established by law for the closing of the polls on election day.

CONFINED VOTERS

Any voter confined by public order and who has not been convicted of treason or a felony under the laws of this state or of the United States applying for ballots by use of the United States mail may make application to the county clerk or election commissioner in the county of their residence September 28 through October 29, 1982, 4 o'clock p.m.

Confined voters may obtain ballots by appointing an agent to personally pick up the ballots during the usual business hours of the county clerk or election commissioner September 28, through November 2, 1982, 12 o'clock noon.

The applications shall be signed by the voter and shall state the voter's political party, registration address and address to where ballots are to be delivered.

Confined voters ballots shall be returned to the issuing officer no later than 10 o'clock a.m. the second day after election.

REGISTRATION

Voter registration for the November 2, 1982 general election closes at 6 o'clock p.m., October 22, 1982.
