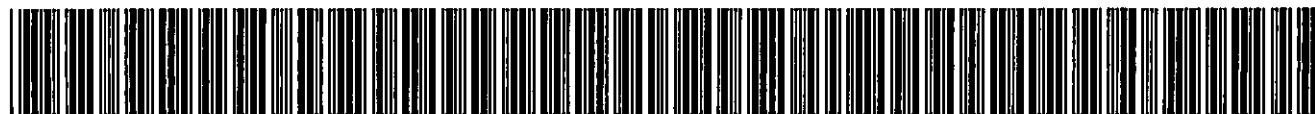

## **ELECTION INFORMATION GENERAL AND SPECIAL ELECTIONS - NOVEMBER 2, 1993**

### **WHAT'S ON THE BALLOT:**

Voters in Virginia will be electing a Governor, Lieutenant Governor, Attorney General and Members of the House of Delegates. In addition, voters in Fairfax County will be electing three Soil and Water Conservation Directors, voting on a referendum for the direct election of school board members, and voting on a school bonds issue. A sample ballot and candidates list is enclosed.

### **ELECTION DAY:**

Polls will be open from 6:00 AM to 7:00 PM on Tuesday, November 2, 1993.

### **COUNTY PROFILE:**

Fairfax County has 189 precincts plus a Central Absentee Voting Election District (CAVED) and contains all or portions of 18 House of Delegates districts. As of September 30, there are 430,000 registered voters in the county. A list of registered voters by district and precinct is enclosed.

### **ABSENTEE VOTING:**

Absentee voting is now in progress for voters with disabilities or voters who will be away on Election Day. The deadline for absentee applications by mail is October 28 and the deadline for in-person voting is October 30. The enclosed card has hours and locations for satellite voting locations.

### **FINANCIAL REPORTS:**

Local candidates' Reports of Contributions and Expenditures are kept on file at the Office of the Electoral Board for public viewing under the Freedom of Information Act. Copies of the reports may be purchased for \$.10 per page. The next financial filings are due by 5:00 PM on October 15 and October 25, 1993.

### **ELECTION NIGHT- UNOFFICIAL RETURNS:**

Unofficial returns will be available in the Board Room of the Government Center beginning at 7:00 PM. Cable channel 16 will also have continuous coverage of the returns as they become available. Copies of final precinct returns will be distributed after all polling places have reported.

One telephone will be reserved for each of the political parties in the Board room. Telephone jacks are available to news agencies in the Press Room behind the Board Room. Members of the press need to make their own arrangements for connecting lines and furnish their own phone. Please call David Mullet or Howard Rubin, 324-3864 in the Office of Communications for these arrangements. Public phones are also located in hallways. (Cellular phones are permitted, but reception inside the building is unreliable.) Election returns from the Board Room can be viewed in the press room.
