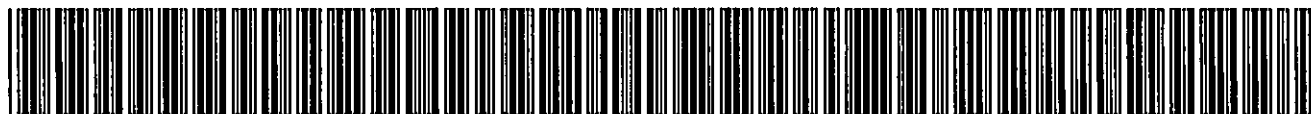

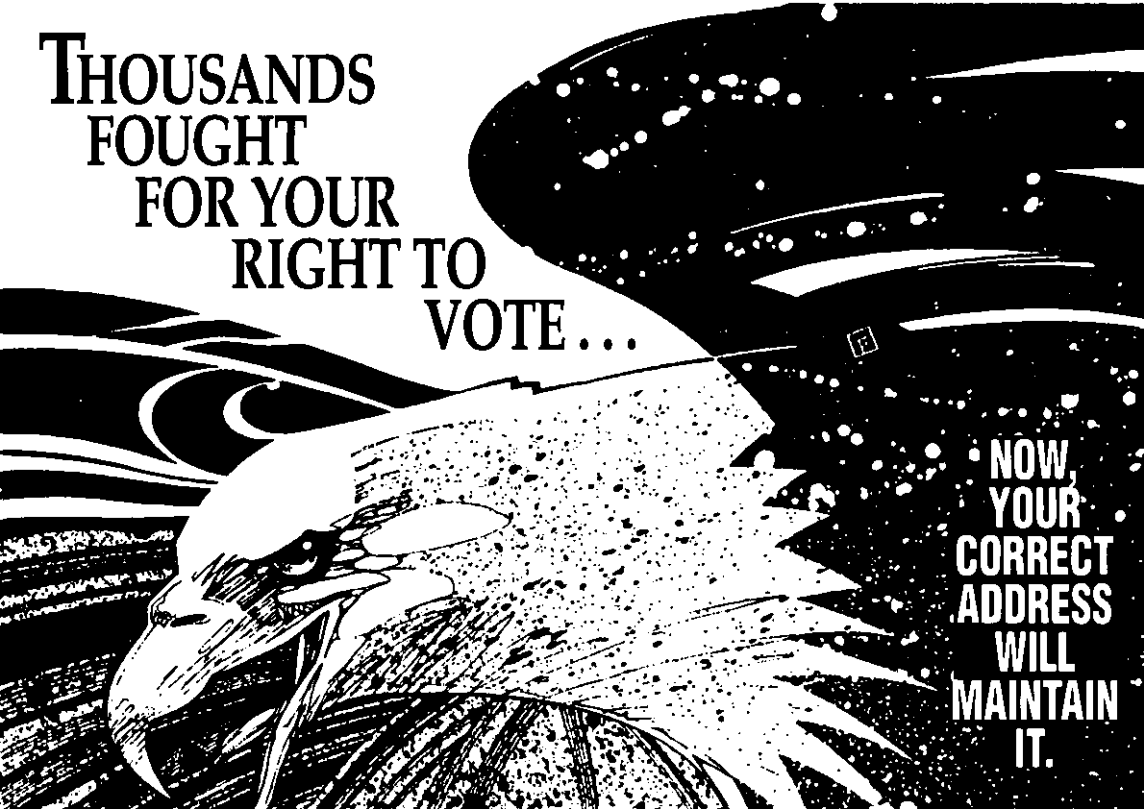

In January, 1991, every registered voter in Louisiana will be canvassed to determine if they are registered at their correct address. Anyone who has not reported their correct address may be removed from the registration rolls. Thousands of Americans have fought for your right to vote. . . now, your correct address will maintain your registration.

### *A Special Word for Rural Voters*

You must send your 9-1-1 address to the Registrar of Voters office by November 15, 1990 so that your precinct information may be verified. You MAY maintain your post office box for mailing purposes but your 9-1-1 address is used for precinct verification. You could be purged from the voter registration rolls if you do not report your 9-1-1 address.

If you are unsure about your 9-1-1 address, please call the 9-1-1 administrative offices at 226-6282. (for Caddo Parish residents only)

Please use the attached form for reporting your correct address. This information must be received by November 15, 1990.
