Dear Friend,

Local advocacy groups in at least 25 states took part in the First National Day of Homeless Voter Registration on July 9.

For the Second National Day on Thursday, September 17, we anticipate that local groups in all 50 states, D.C., and Puerto Rico will conduct voter registration activities.


To insure this event's success and to plan for voter education and "get out the vote" activities, we need your help with the following (Please use the tear-off mail reply form; the deadline is October 1):


- 1) Let us know about the voter registration events you held on the 17th and any other activities during September. Send us your news clippings.
- 2) Send us an estimate of the number of homeless people that you registered to vote this year from the beginning of your campaign to the registration cut-off date.
- 3) Let us know if you are planning to sponsor a local candidate's forum on housing and homelessness.
- 4) Conduct a mock Presidential Preference Poll. People who have registered and also those who plan to register may participate. Make copies of the enclosed ballot, and when you register homeless people to vote, please have them mark their choices on the ballots. We want to receive ballots from all 50 states, D.C., and Puerto Rico.

Tally the results and send them to our offices by **October 1**. In early October, we will issue a news release announcing the results of the first-ever poll conducted on presidential preferences of homeless people. Either send the results by mail or fax 202/265-2615.

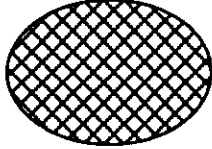

In early October we plan to announce the poll results via the media.

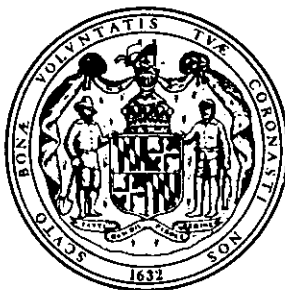
