

# 2020 IFES Virtual USEP Photo and Video Contest "This Is What Democracy Looks Like" Official Rules

## **Sponsor:**

The International Foundation for Electoral Systems, a 501(c)(3) nonprofit organization, is the sponsor of this Contest ("IFES" or "Sponsor").

IFES supports citizens' right to participate in free and fair elections. Our independent expertise strengthens electoral systems and builds local capacity to deliver sustainable solutions.

## **Entry Period:**

The 2020 IFES Virtual U.S. Election Program (USEP) Photo and Video Contest (the "Contest") begins October 7, 2020, at 12:00 a.m. EDT and ends October 30, 2020, at 11:59 p.m. EDT. All entries must be received by October 30, 2020, at 11:59 p.m. EDT.

#### Who May Enter:

The Contest is open to anyone who has reached the age of majority in their state, province or territory of residence at the time of submission, except for individuals serving as judges for the Contest. IFES employees, consultants, fellows and interns (current and former), Board directors and family members of IFES employees may enter. Contest is void where prohibited. Entrants must be registered for the Virtual USEP in order to win.

#### **How to Enter:**

To enter, register for the USEP conference, complete an entry form with the required information and upload a photo or video that complies with the Photo Conditions and Restrictions below. This includes providing a brief description of how the image/video represents one (or more) of this year's themes. Photos must be in digital format. Each entry consists of an online entry form and single image. By providing the required information, uploading a photo/video as directed, agreeing to these Official Rules, and clicking "Submit," you will receive one (1) entry into the Contest subject to the terms of these Official Rules (the provision of information and the uploaded photo collectively

referred to as a "Contest Entry"). All Contest Entries must be submitted electronically via the Virtual U.S. Election Program Website. No print, film or mail-in photos will be accepted for entry into this Contest. Proof of submission is not proof of receipt.

### **Agreement to Contest Rules:**

By submitting a Contest Entry, each entrant agrees to these Official Rules, agrees that the decisions of the Sponsor related to the Contest are final and in its sole discretion, and warrants that his or her Contest Entry complies with all requirements set out in these Official Rules.

# **Photo/Video Conditions and Restrictions:**

In addition to any other requirements set forth in these Official Rules, in order to be deemed eligible for participation and to be deemed a Contest Entry, the photo/video and/or the entrant submitting them must meet the following conditions and restrictions (collectively, the "Photo/Video Conditions and Restrictions"):

- The photo need not be taken with a digital camera; scans of photographic prints are acceptable. All digital photo files must be in JPEG, JPG, PNG or TIFF format, and must be at least 1,600 pixels wide (if a horizontal image) or 1,600 pixels tall (if a vertical image). All videos must be submitted as .MP4 or .MOV files and must be at least 600 pixels in width.
- The entrant must have taken the photo/video within twelve (12) months of the
  entry date. Entries from previous IFES photo contests are not eligible. The
  Sponsor reserves the right to disqualify any person/entrant that violates these
  Official Rules or tampers with/abuses any aspect of this Contest, as solely
  determined by the Sponsor.
- Incomplete or late entries will be disqualified. The photo or video, in its entirety, must be a single work of original material taken by the entrant.
- Black and white photos and photos with minor adjustments are acceptable; these include cropping, minor burning, dodging, contrast and other color correction. High dynamic range images (HDR) and stitched panoramas are NOT acceptable. Watermarks are not acceptable. If the Sponsor does not receive a nonwatermarked version of the entry within 10 days following its request, the entry will be disqualified.
- The photo or video must not defame or invade the publicity or privacy rights of any person, living or deceased, or otherwise infringe upon any person's personal or proprietary rights;
- The photo or video must not, in the sole and unfettered discretion of the Sponsor, contain obscene, provocative, defamatory, sexually explicit or otherwise objectionable or inappropriate content.

- The photo or video must not contain material that is unlawful, in violation of or contrary to the laws or regulations in any jurisdiction where the photo was created.
- The photo or video must not contain corrupted files, viruses, or any other similar software files, the intent of which is to damage the operation of another's computer.
- The photo or video must, in the sole and unfettered discretion of the Sponsor, relate to the thematic category/categories in which it was submitted.
- Photos and videos that include sculptures, statues, paintings, music and other
  works of art will be accepted as long as they do not constitute copyright
  infringement or fraud; provided entrants must be prepared to provide a written
  release form upon request. When photographing or filming the work of others,
  it must be as an object in its environment and not a full-frame close-up of
  another person's art.
- Entrants confirm that they received verbal consent from all individuals ("Subjects") depicted in the photo(s) or video(s) (or no objection from the Subjects, who were clearly aware that the entrant was taking the photo(s) or video(s)), and that they have no reason to believe the Subjects would object to the entrants entering the photo(s) or video(s) into the Contest nor to IFES' use of the photo(s) vide(s) as described in the license granted to IFES below under "Ownership."
- In accordance with our Child Protection Policy, all image and video submissions that include children (those under the age of 18 years) must be accompanied by an IFES-approved consent form that has been completed by the child's parent/legal guardian. A form must be completed for every individual child in the photo and/or video. Email completed consent forms to USEP@ifes.org with Subject "Photo / Video Consent Forms" and include the caption / description of the photo(s) or video(s) the form(s) apply to.

#### **Contest Theme:**

Entrants may submit a maximum of five total (5) photos and videos (in any combination). If an entrant submits more than five (5) photos or videos, content administrators will select five (5) images or videos for consideration. Nonadherence to the theme(s) of the contest can, at the sole discretion of the Sponsor, disqualify photos submitted by entrants.

#### **Democracy Promotion**

Photos should depict efforts to promote inclusive and participatory democracy around the world: from public displays of civil engagement, such as marches and peaceful protests, to preparations for Election Day and voters exercising their rights.

We encourage submission of photos or videos of marginalized groups, such as persons with disabilities, women, youth, Indigenous peoples, and minority populations, among others.

While democracy is a subjective theme, photos and videos that capture the essence some of IFES' most critical work – (1) Voting and Elections, (2) Exercise of Freedoms of Speech and Assembly, (3) Participation and Inclusion, (4) Electoral and Other Technology That Aids Democracy, and (5) Government Transparency, Oversight and Accountability are highly favored.

## **Judging:**

The entries for the main contest theme will be judged in accordance with the criteria as defined below with equal weight assigned to each criterion:

- 1. **Relevance to the Themes:** How well does the photo or video represent the themes of the contest? Does the photo or video offer an engaging response to the questions posed in the contest?
- 2. **Creativity:** Is the subject matter pictured in a unique way? Is the photo or video captured from an interesting point of view? Does the photo or video demonstrate originality?
- 3. **Technical Quality:** Is the photo or video in focus? Is lighting in balance? Is there good use of color, brightness, contrast, saturation and composition?
- 4. **Storytelling:** Does the photo or video tell the story of democracy promotion? Does the photo or video bring together the visual elements to express the purpose of the image?

The photos submitted will be judged by a panel of IFES staff members.

IFES, in its sole discretion, shall determine if any Contest Entry is inappropriate for any reason for public release, including but not limited to publication on the Voting Site. IFES' and judges' decisions are final and binding with respect to all matters relating to this Contest.

Winner must also complete a declaration of compliance, a release of liability, and (except where prohibited by law) a publicity release.

# Ownership of Entries:

Copyright and all other rights remain that of the photographer. Entry in this Contest does not transfer ownership of the rights in the photo submitted, but constitutes a grant to IFES of a royalty-free, worldwide, perpetual, nonexclusive license to display, distribute, reproduce, edit and create derivative works of the Contest Entry photo, in whole or in part, in any media now existing or subsequently developed, for any and all purposes,

including promotional purposes. Any Contest Entry photo(s) used by IFES shall carry the photographer's credit line as deemed appropriate by IFES.

All entrants understand and agree that any image submitted to the Contest may be used by IFES for commercial purposes, including but not limited to marketing and promotion, fundraising, on the IFES website, and in printed publications such as books, brochures or cards, and there will be no monetary compensation or notification to the entrant.

The Released Parties (defined below) do not assume any responsibility for photos submitted for this Contest. By entering the Contest, entrants acknowledge and confirm their ownership of the photo(s); that the Contest Entry does not infringe on the copyrights, trademarks, moral rights, rights of privacy/publicity or intellectual property rights of any person or entity; and that no other party has any right, title, claim or interest in the Contest Entry.

#### Indemnification:

Each entrant agrees to defend, indemnify and hold IFES and its officers, directors, employees, agents and assigns (collectively, the "Released Parties") harmless from and against any and all claims, demands, or causes of action, damages, obligations, losses, liabilities, costs and expenses (including but not limited to attorneys' fees) arising from or related to (i) the entrant's violation of these Official Rules, (ii) the entrant's violation of any third party right, including without limitation any copyright, trademark, trade secret, or privacy right, or (iii) any claim the entrant's Contest Entry caused damage to a third party.

#### Release:

By submitting an entry to the Contest each entrant agrees to release and hold harmless the Released Parties from and against any and all liability and waives all claims or causes of action arising out of or related to participation in the Contest, whether under a theory of contract, tort (including negligence), warranty or otherwise, including any and all injuries, costs, damages, claims and losses of any kind relating to death, dismemberment, personal injury, damage to or destruction of property, rights of publicity or privacy, defamation or portrayal in a false light (whether intentional or unintentional).

# **Limitations of Liability:**

The Released Parties shall not be liable to an entrant or any other person for: (a) any inaccurate information, whether caused by entrants or printing errors; (b) unauthorized human intervention in any part of the Contest; (c) technical failures of any kind, including but not limited to electronic malfunctions of any network hardware or software; (d) technical or human error which may occur in the administration of the Contest or the processing of entries; (e) lost, delayed, misdirected or undeliverable mail or electronic mail; (f) any injury or damage to persons or property, including but not limited to death, which may be caused, directly or indirectly, in whole or in part, from entrant's participation in the Contest.

## Right to Cancel or Suspend Contest or Disqualify Contest Entries:

IFES reserves the right, in its sole discretion, to modify, suspend or terminate this Contest in any of the following events: (i) if for any reason this Contest is not capable of running as planned; (ii) if this Contest or any website associated therewith (or any portion thereof) becomes corrupted or does not allow the proper administration of the Contest and processing of entries in accordance with these Official Rules; (iv) if tampering, unauthorized intervention, actions by entrants, fraud, technical failures, or any other causes, corrupts or affects the administration, security, fairness, integrity or proper conduct of this Contest. In the event the Contest is cancelled before the scheduled conclusion of the Contest or any portion thereof, IFES reserves the right to proceed to judge the eligible entries received (as detailed above) prior to the time of the action or event warranting such cancellation.

IFES shall have the right to disqualify any Contest Entry that it deems to not meet the Photography Restrictions and Conditions, or due to technical, legal, clearance or other problems, or which it deems do not comply with these Official Rules. IFES also reserves the right to disqualify the Contest Entry of any entrant found tampering with the entry process or with the operation of the Contest.

## **Disputes:**

Entrants agree that this Contest shall be subject to and governed by the laws of Virginia, and the forum and venue for any dispute shall be in Virginia, United States of America. Should there be a conflict between the laws of the Virginia and any other laws, the conflict will be resolved in favor of the laws of Virginia. IF THE CONTROVERSY OR CLAIM IS NOT OTHERWISE RESOLVED THROUGH DIRECT DISCUSSIONS OR MEDIATION, IT SHALL THEN BE RESOLVED BY FINAL AND BINDING ARBITRATION ADMINISTERED BY A SINGLE ARBITRATOR OF SPONSOR'S SOLE CHOICE. THE REMEDY FOR ANY CLAIM SHALL BE LIMITED TO ACTUAL DAMAGES, AND IN NO EVENT SHALL ANY PARTY BE ENTITLED TO RECOVER PUNITIVE, EXEMPLARY, CONSEQUENTIAL, OR INCIDENTAL DAMAGES, INCLUDING ATTORNEY'S FEES OR OTHER SUCH RELATED COSTS OF BRINGING A CLAIM, OR TO RESCIND THIS AGREEMENT OR SEEK INJUNCTIVE OR ANY OTHER EQUITABLE RELIEF.

# **Privacy:**

Any information collected by registering to enter the Contest shall be used only in a manner consistent with these Official Rules and with the IFES Privacy Policy. The IFES Privacy Policy governs the information collected by registering to enter the Contest. In addition, if you enter from outside of the U.S., you agree that your personal information may be stored outside of the province, state and/or country in which you reside, and that governmental bodies that have jurisdiction over IFES in the U.S. (e.g., courts and law enforcement agencies) may be entitled to access your personal information.
